# CBCD Summary (July 2026)

---

- We have completed running everyone who had played online from 2020-Feb 1 2024
- Overall rate of Reds: 2.6%
- Total Charged + Warnings: 2097 players
- Overall rate of Reds was dominated by Player Memos (PM)
- IBA update
  - 4 cases finalized since last update (Feb 2026)
    - 3 cases (6 players) found Responsible
    - 1 case (2 players) found not Responsible
  - 6 cases pending (10 players) – 1 not disputing guilt – only discipline
- Path Ahead
  - Run “new online players” (those who started playing online after 2/1/2024)
  - Revisit previously suspended (or warned) players who are off Suspension
  - Revisit “Yellow”
  - Continue to run Members proposed for high-level committees/AC/BoD/HoF
